 - g. 11516 Lyons—Exterior Paint—revised scheme to #6 in color book— Approved as revised at meeting-scheme 6 in color book. Motion made by B Stone and seconded by B Messler.

- h. 11516 Lyons—Shed-wood—Tentatively Approved with comments: Tentative approval with measurements of location specified and roof shingle (architectural) as well as painted same color as house. Motion made by S Lincoln, seconded by B Messler, Yea—R Bay, M McCullers, Nay—B Stone, therefore motion passed 4-1.

- **a. Bulletin Boards**—B Stone was able to negotiate a lower price on the bulletin boards from US Markerboard from \$3,028.33 to \$2,582.32 for an additional 10% volume discount. Motion made by B Stone and seconded by S Lincoln to approve installation by Sentry Management for the agreed price of \$80 per board plus the cost of concrete, all in favor, none opposed, motion passed unanimously. One set of posts were not correct and the holes do not match those of the bulletin board received. Management has contacted the vendor and they requested, if the client was willing, to drill two new holes rather than sending the posts back. B Stone and M McCullers offered to move forward and drill the posts to match the board, and then Sentry could come by to install it at the last location. Motion made by B Messler and seconded by S Lincoln to allow the Board members to make whatever adjustments to the posts as necessary to have posts assembled for installation, all in favor, none opposed, motion passed unanimously.
- **b. Insurance Renewal-3/20/2013 Approval**—Motion made by B Stone and seconded by R Bay to approve the revised quote on commercial insurance package and D&O coverage from Sihle for \$4,089.99 with Tower Hill and a \$2,500 per event deduction, all in favor, none opposed, motion passed unanimously.
